

INVITATION FOR BIDS

1. **Himalayan Distillery Limited (HDL)**, Jawalakhel, Lalitpur, invites sealed bids from registered and eligible Nepalese contractors for the procurement of works as specified in the table below:

The bid submission will follow the 'Two Envelope System' (Technical and Financial) for the construction of the Bottling Hall Building at Birgunj-21, Parsa.

2. Bidders must meet the eligibility and qualification criteria as outlined in the bidding document. Eligible bidders may obtain further information from the Administration Department of Himalayan Distillery Limited, Jawalakhel, Lalitpur.
3. A complete set of bidding documents may be purchased by eligible bidders from the Administration Department of Himalayan Distillery Limited, Jawalakhel, Lalitpur, upon submission of a written application along with a duly attested copy of the valid company/firm registration certificate, VAT and PAN registration certificates, tax clearance certificate for FY 2081/82, and payment of a non-refundable fee as specified in the table above for the bidding documents.
4. Interested bidders must have at least 10 (ten) years of experience in the related field, including experience as a prime contractor in the construction of at least one (1) RCC framed building project having a minimum built-up area of 50,000 sq. ft. or more; and one (1) steel structure project having a minimum covered area of 15,000 sq. ft. or more in the last five years.
5. The bidder must provide evidence of an average annual turnover of NPR 500 million from similar works of best three years within last five years.
6. Sealed bids must be submitted to the above office of Himalayan Distillery Limited, Jawalakhel, Lalitpur, on or before 17:00 hours on the 21st day from the first publication of this notice. Documents received after this deadline will be rejected.
7. Bidders are advised to visit the site and assess the actual conditions before submitting their bids.
8. Bids will be opened on the 23rd day from the first publication of this notice, at the contact office of Himalayan Distillery Limited, Jawalakhel, Lalitpur. The bidders can contact HDL's office if they wish to attend the opening of the bid. However, it is not mandatory for the bidder's representative to be present during the bid opening.
9. If the last date for purchasing the bid form, submitting the bid, and opening the bids falls on a government/office holiday, it will be extended to the next working day. In such cases, the bid validity will be recognized from the original bid submission deadline.
10. Interested bidders must submit all the documents outlined in the bid document; failure to do so may result in the rejection of the bid.
